After the date of original employment, MNSAA does not prescribe how frequently they need to be rechecked. Evidence must be provided in personnel records that a Bureau of Criminal Apprehension check has been completed.

(*MN Statute MN Statute 123B.03 and 122A.18 - Background Checks and Licensing)
